### CHRISTIAN MEDIA IMPACTS AMERICANS

A recent report by the National Religious Broadcasters (NRB) and Barna Group reveals that over 60% of Americans are captivated by Christian media. From TV and radio to podcasts and social media, half of surveyed viewers tune in to Christian media weekly, with 28% labeled as "heavy users," binge-watching across multiple platforms daily. Beyond entertainment, the report highlighted how the content is sparking spiritual growth, emotional resilience, and even swaying election prayers and votes. Roughly two-thirds of Americans called Christian media trustworthy, highlighting how far-reaching the Christian media is as it shapes hearts, minds, and the cultural conversation. Troy Miller, NRB president and CEO, emphasized, "People ... are tuning in. Look, 60% of Americans, that's Americans, not just Christians ... tune in to Christian media in some form, whether it's traditional broadcast radio, television, social media, or on...websites. So, that's a huge number."

## MENTAL HEALTH CLAIMS DEBUNKED

For years, promoters of transgender ideology pushed chemicals for minors to delay puberty and even body disfiguring surgeries, claiming "treatments" are necessary for the mental health of the child. Rather than counsel children while they sort through their dysphoria, which mostly they do, that segment of the medical industry pushed hard for extreme actions with parents even being threatened their child will attempt suicide if they don't agree to pursue that agenda. The National Institutes of Health, presided by President Dr. Jay Bhattacharya, released a study essentially debunking that completely, but it was suppressed. Until now. A report from the Washington Examiner reveals the NIH study "was unceremoniously posted online last month." # **IRAN CANNOT HAVE NUCLEAR PROGRAM**

Decades of Israeli warnings against Iran's nuclear program and preparations for military action culminated on June 13 when Israel deployed "Operation Rising Lion" that attacked Tehran's nuclear facilities and eliminated many nuclear scientists and officers in Iran's senior military leadership. Prime Minister Benjamin Netanyahu asserted, "In recent months, Iran has taken steps that it has never taken before, steps to weaponize this enriched uranium. And if not stopped, Iran could produce a nuclear weapon in a very short time. It could be a year. It could be within a few months, less than a year. This is a clear and present danger to Israel's very survival." On June 21, America targeted and sought to destroy key Iranian nuclear sites throughout Iran and in the capital of Tehran overnight. Defense Secretary Pete Hegseth noted that although America does not seek war, America "will act swiftly and decisively when our people, our partners, or our interests are threatened. Iran should listen to the United States and know that it means every word."

# DISCRIMINATION IS...DISCRIMINATION

On June 5, the Supreme Court sent the case of an employee who contended being the victim of reverse discrimination back to the lower courts. In a unanimous ruling, the justices agreed a federal appeals court was wrong to impose a higher legal standard making it harder for white, male, or heterosexual employees to bring workplace discrimination claims. "By establishing the same protections for every 'individual', without regard to that individual's membership in a minority or majority group, Congress left no room for courts to impose special requirements on majority-group plaintiffs alone," Justice Ketanji Brown Jackson asserted. The case surrounds Marlean Ames, a woman working for the Ohio Department of Youth Services since 2004 as an executive secretary and promoted to program administrator. She contends she was passed over for a management position and demoted to a secretarial role in preference of others identifying with differing sexual orientations because she is heterosexual. **SCRIPTURE:** Mark 12:28-31; Galatians 5:14.

# FDA VOWS MIFEPRISTONE SAFETY REVIEW

Food and Drug Administration (FDA) Commissioner Marty Makary vowed to conduct a review of the abortion pill mifepristone as the drug continues to be subject to scrutiny following a report titled, "The Abortion Pill Harms Women: Insurance Data Reveals One in Ten Patients Experiences a Serious Adverse Event," from the Ethics and Public Policy Center. The report shows a much larger share of women experience adverse effects after taking it than previously believed. A court case challenged the FDA approval of Mifepristone; the abortion drug widely used as a replacement for surgical abortions. The Supreme Court ruled the drug should be available on very narrow grounds based only on the court's claim the plaintiffs hadn't been personally harmed. Now there's going to be a new review of the drug by the FDA itself. "I am committed to conducting a review of mifepristone and working with the professional career scientists at the Agency who review this data," Makary assured. "[The] FDA continues to closely monitor the post-marketing safety data on mifepristone."

# **BOY HERO SAVES FAMILY FROM FIRE**

"In a moment where seconds mattered, he stepped up just like a firefighter would," said Petersburg Fire Rescue & Emergency Services (PFR&ES). A boy knew exactly what to do when his family's home caught on fire in Petersburg, Virginia. When 12-year-old 7th grader Ramir Parker smelled smoke while inside the house on Burks Street, he went to investigate and realized something terrible and dangerous was happening, WTVR reported. Parker was at home with his grandmother and younger brothers when he discovered a fire in the downstairs area of the property. When he smelled smoke, Parker yelled "fire" and grabbed his younger brothers and helped lead everyone out of the house. Instead of panicking or running away when confronted with the fire, Parker "acted" as soon as he caught wind of the devastation ahead. The PFR&ES said his "selfless" actions were "nothing short of heroic". Once they arrived, all occupants were safely out of the home and the person behind their rescue was 12-year-old Ramir. **SCRIPTURE:** Matthew 25:40; Philippians 2:4.
